Sir,

I have the honour to report that today i.e. the 25th June, 2025 at about 3:30 p.m. received a reliable information from our own intelligence about the presence of some anti social social elements at Old Checkon crossing of Imphal East District. Based on the said information, a combined team of CDO/IE Unit and a column of 4 AR under the command of Inspt. N. Devdas Singh, OC-CDO/IE Unit and under the supervision of Shri Y. Joyraj Singh, MPS Addl. SP(Ops)IE rushed to the said area and conducted a C.I. Ops. at 4:20 p.m.

In that, one suspicious unknown person was detained for spot verification at Old Checkon crossing near Ananda Singh Hr. Sec. Academy, Imphal East District. On verification, the detainee identified himself as one **Moirangthem Premjit Meitei @ Papu (47 years) S/o M. Ibomcha Meitei of Soibam Leikai, Imphal East District.** On further verification, the detainee revealed that he kept conceal two pistols at his residence i.e. Soibam Leikai, Porompat PS, Imphal East. Immediately, our team along with the detainee rushed to his residence and on the instance and pointing of the detainee, recovered two nos. of 9 mm Pistols with two magazines and 17 (seventeen) nos. of 9 mm live ammunitions from his bedroom. On further examination, the detainee stated that the above recovered pistols were handed over to him by one Mr. Sanjoy from Yumnam Khunou, Imphal East in the month of July, 2023.

So, the detainee was arrested from his residence i.e. Soibam Leikai, Imphal East District at 5:00 p.m. and seized; (i) **one 9 mm Pistol marked as 'MADE IN USA, CALL - 9 MM, 9 ROUND AUTO PISTOL' along with one magazine,** (ii) **one 9 mm Pistol along with one magazine and (iii) 17 (seventeen) nos. of 9 mm live ammunitions** from his residence i.e. Soibam Leikai, Imphal East District at 5:05 p.m. by observing due formalities.

Therefore, the arrested person along with the seized items are being handed over to you for taking up further necessary legal actions against him.
