On 27/04/2025 at @ 02:00pm, I requested some relatives of mine from Loktak project to received my younger sister at the Loktak project gate, Bishnupur District. On arrival, I noticed the unrest state of my sister and I requested the female members of my family to investigate her body. To which, I found that she was brutally assaulted on her body parts. On further interrogation, it came to light that my sister was assaulted on 25/04/2025 by her husband and his friends. Presently, she is admitted at District Hospital, Churachandpur for medical treatment.

Therefore, I request your good office to register an FIR and book the culprits according to the law of the land.
