I have the honour to report that today i.e. the 27th June, 2025 at about 12:30 p.m. received a reliable information about the presence of some active members of the outfit KCP at Wangkhei Ningthem Pukhri Imphal East District. Based on the said information, team of CDO/IE Unit along with woman police personnel conducted a searched operation at Wangkhei Ningthem Pukhri, Imphal East under the command of Inspt. N. Devadas Singh, OC CDO/IE Unit and under the supervision of Mr. Y. Joyraj Singh, MPS, Addl. SP(Ops)IE at 1:20 p.m.

In that, two unknown suspected person were detained for spot verification at Wangkhei Ningthem Pukhri Mapal, Imphal East. On verification, the detainees identified themselves as; (i) Lalshram Suraj Singh @ Ibungo (33 years) S/o (Late) L. Kumar Singh of Naoremthong Lalsharm Leirak, Imphal West and (ii) Sapam (N) Kshetrimayum (o) Ashangbi Devi (34 years) W/o (Late) Kh. Saratchandra Singh of Khurai Sajor Leikal, Tinsid Road, Porompat PS, Imphal East District. On further verification, both the detainee stated that they are active members of the outfit KCP (PWG) group joined through one Mr. Poirai of KCP (PWG) in the month November, 2024 and presently working under his command and involved in threatening to public and extorted money for raising their party fund. They further stated that today on the advice of the said Mr. Poirai of KCP (PWG), today they collected a sum of Rs. 10, 000/- (ten thousands rupees) from one person.

So, both the detainees were arrested from the spot i.e. Wangkhei Ningthem Pukhri Mapal, near Central Swimming Club, Imphal East District at 1:55 p.m. by observing due formalities. From the possession of the arrestee, Lalshram Suraj Singh, one wallet containing a sum of Rs. 10, 000/- (ten thousand rupees) and one Aadhar card, (ii) one mobile phone (Redmi Note 14 Pro 5G) bearing IMEI no. 867906072741069 & 867906072741077 along with one Jio SIM card bearing no. 9089854467 were seized at the spot i.e. Wangkhei Ningthem Pukhri Mapal, near Central Swimming Club (CSC), Imphal East District the spot i.e. at 2:00 p.m. by observing due formalities. One scooter (TVS Jupiter) brown in colour, bearing regd. no. MN-06/SH-4635 and one mobile phone (Redmi 135G) bearing IMEI no. 866487071417408 & 866487071417416 along with one Airtel SIM card bearing no. 7630932567 were seized from the possession of the arrestee Sapam (N) Kshetrimayum Ashangbi Devi at the spot i.e. Wangkhei Ningthem Pukhri Mapal, near Central Swimming Club, Imphal East District the spot i.e. at 2:05 p.m. by observing due formalities.

Thereafter, the arrested persons along with the seized items are being handed over to you for taking up further necessary legal procedures against them.
