

by which we came and threatened to beat the cab driver also.

Due to shock, I was taken to Community Hall whereby I was
subjected to further harassment due to which I had fainted and
Waghbham Lalit Kumar came & mocked at my condition and
snatched my mother's phone while my mother was trying
to make a call for help so that I could be taken to the
hospital.



On 09-06-2021, my husband took away my elder son (Sarshmani Wahengbam) from my custody at late hours. On 14th May 2025 he was caught red handed by the Meira Paibis along with the woman whom he had extra marital affairs from JNIMS area at odd hours. After that on (15-05-2025) I went to my husband's house to rescue/ get my elder son but no one was there in his house and they hid with the child. On 25/5/2025 at @ 9:30 am I along with my mother Laithangbam (o) Yumnam Romabai Devi aged about 68 years other 8 persons went to my matrimonial home to get my elder son back because my husband is not taking care of our son properly and he is having extra marital affair with that married woman. So, every night he came back home late to his house and my child is being taken care by my elderly mother-in-law. And on that, I entered our bedroom and requested and pleaded him that I wanted to get my son back and look after my son properly at least for few days. My husband threatened me that he will kill me or anybody if I try to get my son back and he had started beating me and after sometime some person also came inside our room and started beating me. One namely Wahengbam Amujao Singh (Happa) aged about 28 years of the locality pushed me forcefully and my chest hit hard on the wooden side of the bed (kangdhon) causing severe pain and injured. One namely Wahengbam (o) Jeena Kangjam grabbed me by my neck and strangled me on the floor and could not breath and pulled my hair and kicked me in many parts of my body and Babita Wahengbam aged about 57 years also helped Wahengbam (o) Jeena Kangjam aged about 45 years W/o W. Lalit Singh in harassing me on that day. Unfortunately, my brother-in-law (elder brother of my husband) namely Wahengbam Lalitkumar Singh aged about 48 years S/o (L) W. Robin Singh kicked me on many parts of my body. On that day, they attack/ beat my mother along other people who came with me. Wahengbam Lalitkumar also took the main lead and used cruel hostile behavior even pulled out the cab driver and shouted that he would break the vehicle by which we came and threatened to beat the cab driver also. Due to shock, I was taken to Community Hall whereby I was subjected to further harassment due to which I had fainted and Wahengbam Lalitkumar came and mocked at my condition and snatched my mother's phone whole my mother was trying to make a call for help so that I could be taken to the hospital.
