I have the honour to report that today i.e. the 28th September, 2025 at about 9:00 a.m. received a reliable information from own source corroborated with the intelligence of 165 TA and 33 AR about the presence of an active member of the outfit PREPAK at Chanung Village and its surrounding area of Imphal-East District. Based on the said information and with the permission/authorization of the authority, a combined team of CDO/IE Unit and 33 AR conducted a C.I. Ops. at the said area under the command of Shri.
