One Mrs. Pamchuiwon Kashak (31 Yrs) W/o Mr. Yaruihor Hungyo of Sorde Village, Kamjong District, Manipur reported to this Police Station stating that, on 12th July, 2025 (Saturday) at around 12 noon, a group of individuals claiming to be members of the NSCN (IM) forcibly attempted to arrest her (who happened to be the victim of FIR No. 1(7) 2019 W-PS UKL U/S 376/506 IPC and 354-A IPC) from a shop located at the opposite of ZEO Office, Phungreitang, Ukhrul. Her husband, Mr. Yaruihor Hungyo. their infant son and she herself were taken to the Wung Tangkhul Region (WTR) Office at Harkui Kathe Tang. Ukhrul on the eastern outskirts of the town. There, they were threatened and coerced to withdraw the case (the above mentioned FIR case) filed against Mr. Assurance Raikhan (accused). Although she was released on account of their baby, her husband was detained, chained, and physically assaulted right before her eyes. They categorically told her that he would not be released until she produced proof of withdrawing the case With the efforts of her family, relatives, and concerned friends, her husband was finally released on 15th July, 2025 (Tuesday) around 1 pm, but only after sustaining multiple injuries and bruises. They were forced to sign an undertaking stating that she must comply with their demands (demand of the NSCN-IM to withdraw the case) at any time, failing which they would face serious consequences. They are now living under constant threat and grave insecurity. The integrity of the ongoing trial is also at risk, facing undue interference and intimidation orchestrated by Mr. Assurance Raikhan. Her husband, being a government servant, was further subjected to professional consequences due to his forced absence from duty during his illegal detention. Mr. Assurance Raikhan, presently out on bail, has directly and indirectly threatened her and their family on multiple occasions. Even after the said incident, he continues to influence NSCN (IM) members to act as his agents of intimidation against them. In light of the above, she humbly requested the Ukhrul Police to take immediate and appropriate action against Mr. Assurance Raikhan for sponsoring and orchestrating such act of kidnapping, assault, and intimidation; to ensure the safety and protection of her and her family from further threats and to safeguard the integrity of the ongoing trial so that it proceeds without coercion obstruction, or interference.

On receipt of the complaint report, the Officer-in-charge, Ukhrul Police Station registered a regular case under FIR No. 07(09)2025 UKL-PS, U/S 137(2)/135/127(3)/351(2)/3(5) BNS

Subject: Complaint Against Kidnapping, Assault and Threat by Mr. Assurance Raikhan

I respectfully submit this complaint regarding an incident of abduction, physical assault, and life-threatening intimidation connected to the above-referenced case, which is currently under trial before the Hon'ble Court of the District & Sessions Judge, Ukhrul.

On 12th July, 2025 (Saturday) around 12 noon, a group of individuals claiming to be members of the NSCN (IM) forcibly attempted to arrest me, the victim in the aforementioned case, from a shop located opposite the ZEO Office, Phungreitang, Ukhrul, My husband, Mr. Yaruihor Hungyo, our infant son, and I were taken to the Wung Tangkhul Region (WTR) Office at Harkui Kathe Tang, on the eastern outskirts of the town.

There, we were threatened and coerced to withdraw the case filed against Mr. Assurance Raikhan. Although I was released on account of our baby, my husband was detained, chained, and physically assaulted right before my eyes. We were categorically told that he would not be released until I produced proof of withdrawing the case.

With the efforts of our family, relatives, and concerned friends, my husband was finally released on 15th July, 2025 (Tuesday) around 1 pm, but only after sustaining multiple injuries and bruises (medical report enclosed). We were forced to sign an undertaking stating that I must comply with their demands at any time, failing which we would face serious consequences.

We are now living under constant threat and grave insecurity. The integrity of the ongoing trial is also at risk, facing undue interference and intimidation orchestrated by Mr. Assurance Raikhan My husband, being a government servant, was further subjected to professional consequences due to his forced absence from duty during illegal detention.

Mr. Assurance Raikhan, presently out on bail, has directly and indirectly threatened me and my family on multiple occasions. Even after the sald incident, he continues to influence NSCN (IM) members to act as his agents of intimidation against us.

In light of the above, I humbly request the Ukhrul Police to take immediate and appropriate action against Mr. Assurance Raikhan for sponsoring and orchestrating such act of kidnapping. assault, and intimidation; to ensure the safety and protection of me and my family from further threats, and to safeguard the integrity of the ongoing trial so that it proceeds without coercion,

With utmost urgency, I seek justice and protection under the law.
