I have the honour to report that today i.e. the 13<sup>th</sup> April, 2025 at about 8:00 p.m. received a reliable information about the presence of some anti social elements likely to carried out pre-judicial activities at Wangkhei area of Imphal East District. Based on the said information, teams of CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC-CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops)Imphal-East rushed to the said area and conducted C. I. Ops. at the said area at about 8:30 p.m.

As part of the searched operation, random frisking and checking was conducted to the suspected passersby at Wangkhei near Eastern Ground, Imphal East. In that, one suspected person was detained for verification and spot checking. On checking the detainees body; one 9 mm Pistol loaded with 15 (fifteen) live rounds in the magazine and two nos. of mobile phones were recovered. On verification, the detainee identified himself as one Ahanthem Rajesh @ Nandakishore @ Parihan (38 years) S/o (Late) Ahanthem Nandakumar of Chingmerong Lei-Ingkhol, Imphal East District. On further verification, the detainee stated that he is an active cadre of the outfit UNLF (Pambei) group joined the outfit through one Mr. Luwangamba of UNLF in the year 2001 and got his basic military training in the same year at Sajik Tampak, Manipur for three months under the command of one s/s – Sergeant Atangba of UNLF with allotted army no. 1440 of 22<sup>nd</sup> batched. The detainee further stated that he is presently holding the rank of s/s – Corporal and holding the post of s/s – PSO (Personal Staff Officer) presently working under the command of one s/s – Finance Secy. Tonsana of UNLF (Pambei) group.
