I have the honour to report that today i.e. the 17th April, 2025 at about 7:00 a.m. received a reliable information from our own source about the concealment of large nos. of arms, ammunitions and explosives at Chingkhei Ching, Imphal East District. Based on the said information, a combined team of CDO/IE Unit and a column of 33 AR, led by myself were organized to conduct a searched operation at the said area under the command of Inspt. Kh. Henery Singh, Officer-in-Charge, Commando Imphal East Unit and under the supervision of Shri. Y. Joyraj Singh, MPS, Addl. SP (Ops) Imphal East District. On reaching the said area, the combined team was divided into four groups and conducted the searched operation. During the operation, one sack bag, white in colour, and one plastic tarpaulin were found hiding inside a bush at the western side foothill of Chingkhei Ching, Imphal East District. On opening the sack bag and unwrapping the plastic tarpaulin, the under noted arms, ammunitions and explosives were found and recovered:

1. 1 (one) no. 7.62 SLR rifle marked as '95333' with one magazine,
2. 1 (one) no. of 12 bore single barrel gun marked as 'K46783'.


