Sir,

I have the honour to report that on 18/08/2025, at around 9:00 p.m., two groups totalling around 30 individuals, where one group led by Khaidem Borish Singh, aged about 20 years, S/o Khiadem Deny Singh of Kongpal Khaidem Leikai, Imphal East and another group led by Rk. Lagonba Singh, aged about 22 years, S/o Rk. Bilasana Singh of Singjamei, Imphal West involved in a fight near the junction between NH-202 (Imp-Ukl Road) and Angom Leikai road along Angom Leikai road. Khaidem Borish Singh called his friend namely Yumkhaibam Budha Singh, aged about 25 years, S/o Yumkhaibam Sobha Singh of Khurai Chingangbam Leikai, who is my nephew at the spot to assist him.

After learning that Yumkhaibam Budha Singh has gone to assist Khaidem Borish, my two sons namely Yumkhaibam Premkant Singh and Yumkhaibam Rohit Singh who are his cousin brothers, went to the place of incidence to make sure that their brother was safe and sound. Upon reaching, the place of incident, the fight had stopped. So, my two sons left the spot and were returning home. However, upon reaching Ng. Mani College at around 9:30 pm, a group of around 30-40 persons led by Thangjam Jackson, aged about 23 yrs S/o Th. Ingocha of Khurai Laishram Leikai stopped my two sons and assaulted with weapons from behind without giving any reason, thereby causing severe injuries on their persons. As a result of the assault, both my sons lost their consciousness.

Thereafter, some local Meira Paibis and members of local club of Chairen Thongkhong rescued both my sons and took them to Chairen Thongkhong Meira Paibi Sang.

In the meanwhile, one person, namely Biken Yaikhom, aged about 47 years, S/o Yaikhom Baosingh Singh of Khurai Kongpal Laishram Leikai, Imphal East, Manipur through cell phone informed me about the said incident and asked me to appear immediately before the said Meira Paibis Shang. As such, I went at the said place. Upon reaching, I found only four out of the many unknown local individuals who were involved in attacking my sons present inside the said Meira Paibi Shang for compromising regarding the said matter. In the meantime, Biken Yaikhom of Khurai Laishram Leikai who was present at the Meira Paibi Sang, directed the 4 (four) unknown local individuals to leave the said Meira Paibi Shang in order to hide their involvement in the said incident and before leaving the Meira Paibi Shang, one individual among the 4 (four) unknown local individuals threatened to kill both my sons if we file any complaint against them before any Police Station. Hence, delay in lodging this complaint.

It is, therefore, requested to take up necessary actions against all the offenders who were involved in committing the said offence against my two sons.
