Subject: Report.

Sir,

I have the honour to state that, on 25/09/2025, at about 00.50 am, based on a reliable input given by Youth Against Drug Alcohol Manipur (YADAM), M & N Sector QAT CRPF and Range Imphal QAT CRPF that, two person were loading huge quantity of cough syrup containing codeine phosphate, Samplex + (tramadol) capsules and Nitrapal-10 (Nitrazepam) tablet in a Autorickshaw bearing regd No MN06SB 7957 at the gate of Tharoijam Brajagopan aged @ 40 yrs s/o (L) Th. Thambaljao of Khurai Sajor Leikai, Tharoijam Leirak near Tharoijam Pukhri, Imphal East District. The said information was reduced in writing and was placed before the Superintendent of Police/NAB, Manipur and I obtain the search authorisation to search the same Autorickshaw. Then, I along with a team of NAB-PS, Manipur was constituted for execution the information. The combined team of NAB-PS, YADAM volunteers, Dett 232 (M) Bn., F/Coy 232 Bn and B/Coy 232 Bn of CRPF rushed towards Khurai Sajor Leikai, Tharoijam Leirak, Tharoijam Pukhri, Imphal East.

On reaching the spot at @ 1.35 am, we saw two persons loading some suspected illegal items at the gate of Tharoijam Brajagopan aged @ 40 yrs s/o (L) Th. Thambaljao of Khurai Sajor Leikai, Tharoijam Leirak near Tharoijam Pukhri, Imphal East District. On that, the combined team immediately act to nabbed the two persons but, one person escaped from police arrest taking advantage of the dark night and narrow local streets. Thus, one person i.e driver of the autorickshaw was detained at the spot. Accordingly, I requested a gazetted officer i.e Asst. Commandant/109 Bn. CRPF, L. Ibomcha Singh to witness the procedure drill of search, seizure & arrest and he agreed to witness the same. Further, as requested two civilian present at the spot namely 1) Yaikhom Biken Singh 45 yrs s/o Y. Babu Singh of Khurai Konsam Leikai, Imphal East, Manipur and 2) Laiphakpam Radhamani Devi 55 yrs w/o N. Loken Singh of Khurai Konsam Leikai, Imphal East agreed to witness the same. However, MFU Imphal West, Lamphel was tried to contact for requisition to assist the procedure drill of search, seizure & arrest but unable to communicate.

In presence of the witnesses, the detainee was identified himself as **Meisnam Geetchandra (38) S/o M. Nando Singh of Khurai Konsam Leikai, IE District**. On checking and searching the Autorickshaw bearing regd No MN06SB 7957, found one white plastic container with blue lid labelled Nova Dairy Rich, one plastic container maroon and white colour labelled AngZyme Power, one plastic carry bag blue red and yellow stripe, one white gunny bag, and one yellow gunny bag was found. At the same time, one green colour plastic bag was found in the middle sit of the Autorickshaw.

On opening the green colour plastic bag, it was found containing cough syrup containing codeine phosphate. It is to mentioned that, the exact name of the cough syrup could not be readable as all the labelled on the bottles was washed out by water and found wet but contains of codeine phosphate can be detected randomly. **On counting, it was found 61 nos. of cough syrup containing codeine phosphate and the same was put in its original container i.e green colour plastic bag which was properly bind and sealed with wax and marked as 'A' as parent exhibit.**

On opening the white plastic container with blue lid labelled Nova Dairy Rich, plastic container maroon and white colour labelled AngZyme Power, plastic carry bag blue red and yellow stripe, white gunny bag and yellow gunny bag, all were found containing Samplex + (tramadol) capsules and Nitrapal-10 (Nitrazepam) tablet.

Accordingly, 600 strips of Samplex+ capsules containing Tramadol (in total 600 x 24 cap. = **14400 cap.**) were put in a brown gunny bag which was properly bind and sealed with wax

containing Tramadol (in total $371 \times 24 \text{ cap.} = 8904 \text{ cap.} + 16 \text{ cap} = 8920 \text{ cap.}$) were put in its original container yellow gunny bag which was properly bind and sealed with wax and marked as 'C' as parent exhibit. **All together, 23320 capsules (14400 cap + 8920 cap) of Simplex+ (Tramadol).** Then, **139 Strips of Nitrapan-10 (Nitrazapam) Tablets (139 x 10 Tablets = 1390 Tablets)** were also put in its original container i.e white gunny bag which was properly bind and sealed with wax and marked as 'D' as parent exhibit. All the paper covers of Simplex+ Cap. (tramadol) and Nitrapan-10 (Nitrazapam) Tablets were put in a yellow colour gunny bag which is bind and marked as E.

Finally, 1) one green colour gunny bag which was properly bind and sealed with wax, marked as 'A' containing 61 Nos. of cough syrup containing codeine phosphate, 2) One brown gunny bag which was properly bind and sealed with wax marked as 'B' containing 600 strips of Simplex+ capsules containing Tramadol (in total $600 \times 24 \text{ cap.} = 14400 \text{ cap.}$), One yellow gunny bag which was properly bind and sealed with wax marked as 'C' containing 371 strips and 16 capsules of Simplex+ capsules containing Tramadol (in total $371 \times 24 \text{ cap.} = 8904 \text{ cap.} + 16 \text{ cap} = 8920 \text{ cap.}$), one yellow colour gunny bag which is bind and marked as E containing the paper covers of Simplex+ Cap. (Tramadol) and Nitrapan-10 (Nitrazapam) Tablets, one white plastic container with blue lid labelled Nova Dairy Rich and one plastic container maroon & white colour labelled AngZyme Power were seized from the possession of **Meisnam Geetchandra (38) S/o M. Nando Singh of Khurai Konsam Leikai, IE District** on the same day at 3.00 am by preparing a weighing and seizure memo.

At the same time, one driving licence in name of Meisnam Geetchandra, one registration document of Autorickshaw, one Autorickshaw bearing No. MN06SB 7957 one mobile phone Redmi 12 5G bearing No. 7005112600 were seized on production of **Meisnam Geetchandra (38) S/o M. Nando Singh of Khurai Konsam Leikai, IE District** on the same day at 3.05 am by preparing a seizure memo.

Accordingly, **Meisnam Geetchandra (38) S/o M. Nando Singh of Khurai Konsam Leikai, IE District** was arrested on the same day at 3.10 am by preparing an arrest memo at the spot. I obtained the signatures of the arrestee and witnesses on the parent exhibit, weighing & seizure memo, seizure memo and arrest memo in which I also put my signature on the same.

On preliminary questioning he revealed that, Tharoijam Brajagopan aged @ 40 yrs s/o (L) Th. Thambaljao of Khurai Sajor Leikai, Tharoijam Leirak near Tharoijam Pukhri, Imphal East District frequently called me on mobile phone asking for reserve trips of my Autorickshaw to carry some items (unknown) from Khabeisoi. I went for the trip along with Tharoijam Brajagopan and loaded full seven gunny bags. He asked me to kept the seven gunny bags at my home and offer me Rs. 10/- per bottle. Thus, I kept the same in my home and went for another trip from the house of Tharoijam Brajagopan where I get arrested. He further stated that, the person who was escape from the spot during his arrest was Tharoijam Brajagopan aged @ 40 yrs s/o (L) Th. Thambaljao of Khurai Sajor Leikai, Tharoijam Leirak near Tharoijam Pukhri, Imphal East District.

Accordingly, The combined team along with the arrested accused person rush towards his residence i.e Khurai Konsam Leikai, Meisanam Leirak at @ 3.20 am. We found one white gunny bag on veranda at his residence. I requested a gazetted officer i.e Asst. Commandant/109 Bn. CRPF, L. Ibomcha Singh to witness the procedure drill of search, seizure & arrest and he agreed to witness the same. Further, as requested two civilian present at the spot namely 1) Laiphakpam Radhamani Devi 55 yrs w/o N. Loken Singh of Khurai Konsam Leikai, Imphal East and 2) Konthoujam Ranjana Devi 45 yrs w/o Konsam Manihar of Khurai Konsam Leikai, Chingjoibi Leirak agreed to witness the same. In presence of the witnesses, further search was conducted found a plastic carry bag blue red & yellow stripe and five gunny bags yellow, white, green, yellow & white colour respectively were found inside his room. On opening the plastic carry bag blue red & yellow stripe and all six gunny bags, all were found containing Borcodex Cough Syrup containing codeine phosphate. 300 bottles each of Borcodex Cough Syrup containing codeine phosphate were put in four separate gunny bags marked as F - white colour, G-white colour, H- white colour and I-Yellow colour respectively which were properly bind and

bind and sealed with wax as parent exhibits. Altogether, 1322 Bottles ($300 \times 4 = 1200 + 122$) of Borcodex Cough Syrup containing codeine phosphate.

In presence of the witnesses, four gunny bags marked as F - white colour, G-white colour, H- white colour and I-Yellow colour which were properly bind and sealed with wax containing 300 bottles each of Borcodex Cough Syrup containing codeine phosphate, one gunny bag white in colour marked as J which were properly bind and sealed with wax containing 122 bottles of Borcodex Cough Syrup containing codeine phosphate and one gunny bag yellow in colour marked as K which was bind and sealed containing empty gunny bags were seized from the possession of **Meisnam Geetchandra (38) S/o M. Nando Singh of Khurai Konsam Leikai, IE District** on the same day at 4.10 am by preparing a weighing and seizure memo.

The whole process of search and seizure was videographed in my eSakshya account and certificate under section 63(4)(c) is generated.

Hence, the arrested accused person along with the seized items along with the relevant documents were placed before you for taking necessary actions.
