Today i.e. 07/09/2025 at 10:05 pm received an information that on the same day at around 9:55 pm 1(one) Pulsar N-200, Black in Colour bearing regd.no. MN01AN0100, proceeding from Lamlong side towards Sawombung side along NH-202(Imphal-Ukhrul Road) collided with 1(one) Dio Scooter, white in colour bearing red. No. MN06SB 3856 coming from opposite direction at Chingarel Tejpur near Lamjingba Maheikol due to rash and negligent driving/riding on the part of the driver/rider of both the vehicles. As a result of which both the driver/rider got injuries on their persons and evacuated to hospital for medical treatment. Both the vehicles were also damaged.
