SP(Ops) Imphal East District rushed to the said area and conducted a searched exercation in the general area of Chingkhei Ching and and its surrounding area of Imphal East District at about 5.00 on. During the search operation, found two nos. of sack bags suspected to be containing arms, ammunitions and explosives hidden in a bush at the foothill of Chingkhei Ching, Imphal East. On opening the sack bags the macrnoted arms, ammunitions, explosives and other items were found and recovered;
