I have the honour to report that today i.e. the 29th April, 2025 at about 4.00 a.m. received an information from a reliable source about the concealment of a huge nos. of arms, ammunitions and explosives by unknown arms miscreants in general area of Chingkhei Ching and its surrounding area of Imphal East. Based on the said information, a combined team of CDO, Imphal East District and 33 AR, assisted by Jem. N. Nungshibabu Singh of JRB/CDO/IE Unit under the command of Inspt. Kh. Henery Singh, OC CDO/IE Unit and under the supervision of Shri. Y. Joyraj Singh, MPS Addl. SP(Ops) Imphal East District rushed to the said area and conducted a search operation in the general area of Chingkhei Ching and its surrounding area of Imphal East District at about 5.00 a.m. During the search operation, found two nos. of sack bags suspected to be containing arms, ammunitions and explosives hidden in a bush at the foothill of Chingkhei Ching, Imphal East. On opening the sack bags the undornoted arms, ammunitions, explosives and other items were found and recovered;

1 (one) no. of 12 bore Single barrel marked as 'K14971'.

1 (one) no. of 12 bore Single barrel marked as 'K31682'.

1 (one) no. of 12 bore Single barrel marked as 'TN7358'.

1 (one) no. .303 sniper rifle marked as 'IN2629 2015'.

1 (one) no. of 9mm Pistol with magazine.

1 (one) no. of Pistol holster.

2 (two) nos. of No. 36 Hand Grenade with arming ring.

10 (ten) nos. of 7.62x39 mm live ammunition.

5 (five) nos. of Tear smoke shell (Normal).

2 (two) nos. of Helmet and

4 (four) nos. of BP Plate.

Accordingly, the above recovered arms, ammunitions, explosives along with the two sack bags were seized at the spot i.e. foothill of south western side of Chingkhei Ching Hill range, which is about 200 metres away to the southern side of Mega Manipur, School, Imphal at 5:41 a.m. by observing due formalities. Thereafter, the seized items are being handed over to you for taking up further necessary legal procedures.
