That, on 13/8/2025 at about 6:30 pm I came across Facebook comments on post with URL <a href="https://facebook.com/share/p/16q3dNDNW4">https://facebook.com/share/p/16q3dNDNW4</a> shared by one Facebook page namely MKP F Moirang Kendra with URL <a href="https://www.facebook.com/share/1XwQTL43Lt/">https://www.facebook.com/share/1XwQTL43Lt/</a> by one unknown Facebook user name "Laishom Chandrakumar" with URL <a href="https://facebook.com/laishom.chandrakumar">https://facebook.com/laishom.chandrakumar</a> has made several defamatory and religiously offensive remarks against me on the social media platform Facebook. In a public comment, he referred to me as "Okchaba", which translates to "consumer of pork". As a practicing Muslim, the consumption of pork is strictly prohibited in our religious Islam.

Furthermore, Mr. Chandrakumar Singh has previously portrayed me in a derogatory manner by calling me a drug addict and even referring me as a dog in his comments. These statements are not only deeply offensive but also damaging to my personal dignity, religious identity, and social reputation. Copies of the relevant screenshots of his comments are enclosed herewith for your

His repeated use of such inflammatory and abusive language on a public platform is a clear violation of my constitutional right to religious freedom and protection from hate speech.

I, therefore, earnestly request you to kindly initiate appropriate legal action against the unknown Facebook user under the relevant provisions of the BNS for deliberate and malicious acts intended to outrage religious feelings, defamation, and statements creating or promoting enmity, hatred or ill-will between classes.

I shall remain grateful for your prompt and just intervention in this matter.
