I have the honour to report today i.e. 24/06/2025 at around 1.10 pm received a reliable input from own source regarding presence of some armed miscreants at Loktak Lake Champu Khangpok near Karang area who are involved in extortion and threatening general public, government office, businessmen, local shopkeepers, local fishermen etc. Based on the input, a joint team of CDO-BPR led by Sub. Y. Shaktishen Singh OC/CDO-BPR assisted by SI Ph. Birkumar Singh, SI N. Nandalal Singh, SI Ph. Sunil Singh, SI S. Ojit Singh, Jem. A. Shanti Singh, ASI M. Inaotomba Singh, ASI M. Romesh Singh, Hav. Kh. Kunje Singh with civil teams of CDO-BPR under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops) Bishnupur along with a column of 2 JAK LI led by Maj. Kinobabu under the overall guidance of Shri. Ksh. Ravikumar Singh, IPS, SP-Bishnupur immediately rushed to the said area using motor boats and local boats and conducted an extensive search operation by cordoning the suspected floating huts to prevent any unwanted activities.

During the course of cordon and search operation, teams of 2 JAK LI cordon the outer, teams of SI Ph. Birkumar Singh and SI N. Nandalal Singh approached from the eastern side, teams of SI Ph. Sunil and SI S. Ojit Singh from the western side, teams of Jem. A. Shanti Singh and ASI M. Inaotomba Singh from

Commandos, one unknown person was seen running as if trying to escape from the approaching Commando teams by pulling out one small weapon with an intention to attack to our team. In response, the commandos tactfully chased and overpowered him about 100 mtrs far from the hut and snatched 01(one) 9mm pistol with a magazine along with two live rounds (one in the chamber). On spot verification, the unknown person identified himself as Mutum Manaocha Singh @ Khullakpa (44) years S/O M. Tolpishak Singh of Tronglaobi Makha Leikei. On examination, he disclosed that he is a Fighting Commander of Kangleipak Communist Party (People War Group) KCP(PWG) and he joined in September, 2023 through one Awangba, Chairman of KCP(PWG). So, he was arrested from the spot i.e. floating hut at Loktak Lake Champu Khangpok near Community Hall at 4.40 pm by observing proper formalities. Further on searching the area, (1) 01(one) side bag black in colour, (2) 01(one) wallet brown in colour, (3) 01(one) Redmi 9A mobile phone having one Jio SIM card bearing mobile no. 8413851030 and (4) 01(one) Redmi Mobile phone having one airtel SIM card, (5) 01(one) Gas Cylinder, (6) 01(one) gas stove, (7) 01(one) Solar Panel, (8) 02(two) Blankets, (9) 01(one) table Fan, (10) 01(one) Steel bucket, (11) 01(one) steel tea pan, (12) 03(three) plates, (13) 01(one) pressure cooker and (14) 02(two) steel glasses, (15) 01(one) water jar, (16) 01(one) plastic table and (17) 01(one) mat were recovered. The above mention recovered items along with the 9mm pistol with a magazine and two live, rounds are seized at 4.45 pm by observing proper formalities from the spot.

On further questioning, he disclosed that, he had kept concealed arms and ammunitions at Nachou Awang Leikai Patton Sallam Maton someday back. Accordingly the joint teams led by SP-Bishnupur along with Addl. SP(Ops)/BPR, OC-CDO/BPR, CDO teams, a team of KBL-PS and a column of 2 JAK LI with the arrested person immediately rushed to the said area and on pointed out by the arrested person, (1) the arrested person immediately rushed to the said area and on pointed out by the arrested person, (1) 01(one) MA-1 Rifle with 03(three) magazines, (2) 31(thirty-one) nos. of 5.56 mm live ammunitions, (3) 02(two) SMG Carbine with 02(two) magazines wrap with polythene sheet and packed in a rubber tube concealed under the earth were recovered and seized at 8.34 pm from the spot i.e. Nachou Awang Leikai Patton Sallam Maton by observing proper formalities.

He further disclosed that, he had involved in extortion and threatening the general public including the local fishermen, government offices, businessmen, shopkeepers in Bishnupur District and the outfit used the huts as their camp hideout.

Hence, the arrested person along with the seized items are being handed over to you for taking further necessary legal action against him.







He further disclosed that, he had involved in extortion and threatening the general public including the local fishermen, government offices, businessmen, shopkeepers in Bishnupur District and the outfit used the huts as there camp hideout.

Hence, the arrested person along with the seized items are being handed over to you for taking to ther necessary legal action against him.
