I am a contract NHPC employee posted at Power House Station NHPC Ltd. Leimatak for the past 12 years. I was allotted quarter no Type II/09 Jeevan Nagar Leimatak. Due to the current communal clash, I along with my family members had left my quarter on 07-05-2023 leaving behind all my valuable household items, kitchen items, apparels, tools, electronic goods, LED TV sets, gold ornaments as well as some cash inside my quarter.
