I had allotted a quarter at Old Balvidya School, Leimatak. Due to the current communal clash, I along with my family members had left my quarter on 07/05/2023 leaving behind all my valuable household items, kitchen items, apparels, tools, electronic goods, gold ornaments, some cash as well as one bike bearing registration no. MN01V 6523.

However, on 28/12/2023 at around 2:00 PM, I was being informed that my quarter lock had been broken and all my household items which I had left had been vandalized and looted/stolen by some
