I have the honour to state that I am a contract NHPC employee posted at Power House Station NHPC Ltd. Leimatak for the past 7 years. I had allotted a quarter no. Type II/C-5. Due to the current communal clash. I along with my family members had left my quarter on 07/05/2023 leaving behind all my valuable household items, kitchen items, apparels, tools, electronic goods, LED TV sets, gold ornaments as well as some eash inside my quarter.

However, on 15/02/2024 at around 4:00 PM, I was being informed that my quarter lock had been broken and all my household items which I had left had been looted/stolen by some unknown Kuki miscreants. The approximate value of the looted/stolen items is around Rs. 10,71,000(Ten Lakhs Seventy-One thousand). I cannot report timely as I had no proper knowledge and understanding.
