Today i.e the 1st Oct, 2025 at around 07:20 pm information was shared by SP Chandel regarding presence of a drug smuggler namely Lunkhopao Haokip of T. Kotlen village near Longja village in which four police teams led by SP Chandel & Addl. SP/(Ops) acted promptly to cause arrest compelling to reach the spot without delay. Cordoned the house and searched thoroughly however, the suspected person and the contraband items were not found during the conduct. On the way back at around 09:20 pm from the spot the police teams were stopped by irate mob at Longja village junction obstructing further movement of police personnel in the Kuki inhabited areas in which 4(four) police vehicles were damaged by the violent mob. The police teams were stopped by the irate mob numbering about 700/800 men, women & youths without any valid reason during the discharge of police duty.
