Sir,

I am to report that on 05/07/2025 at around 5:30 pm, received a reliable input provided by 19 AR and 2-JAKLI corroborated with our own source regarding hideout of some arms and ammunitions suspected to be concealed by some unknown arm miscreants at Nepali Basti, Santipur area under Loktak-PS. Immediately a combined teams of CDO/BPR including civil team along with a column of 2-JAKLI, 19 AR and a team Loktak-PS led by self assisted by SI Ph. Sunil Singh, SI N. Nandalal Singh, Hav. No. 1299017 S. Kamei, Hav no. 092001230 Ch. Bobo Singh and Hav. No. 1219055 Kh. Kunje Singh under the command of Sub. Y.Shaktishen Singh, OC/CDO-BPR under the supervision of Shri. Amarjit Singh Lamabam, Addl. SP (Ops), Bishnupur and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS SP- Bishnupur conducted an extensive search operation at Nepali Basti, Santipur area after giving due information to the concern authority in that, the following Arms cache which were kept concealed at the southern side of Nepali Basti, Santipur, were recovered :-

1. 1 no. of SLR Rifle bearing regd. no. S2238.
2. 1 no. of .303 Rifle with one empty magazine bearing regd. no. 80299M.
3. 2 nos. of empty AK magazines.
4. 2 nos. of improvised mortars.
5. 7 nos. of Baofeng handsets.
6. 3 nos. of Tear smoke grenade.
7. 1 no. of stun grenade.
8. 3 nos. of ILLUM Para bomb.
9. 6 nos. of 12 bore live cartridge.
10. 3 nos. of .303 missed rounds.
11. 1 no. of improvised mortars Tripod.
12. 1 no. of grenade marked as 90 MK 3.
13. 8 nos. of Baofeng chargers.
14. 2 nos. of BP Jacket.
15. 08 nos. of BP Helmet.
16. 1 pair of shoe.
17. 2 nos. of Belt.

The above mentioned arms cache which were suspected to be hidden by some unknown arm miscreants, were seized at 6:49 pm and no arrest was made. The extensive search operation was concluded at 7:20 pm. The seized items were handed over to you for further necessary action.
