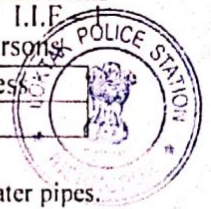

Sir,

I have the honour to state that on 30/07/2025 at around 2:30 P.m. I, Serto Ason Kom (50) Chief of Lower Kom Keirap S/O (L) S. Soneikhup Kom of Lower Kom Keirap Village, along with some villagers had went to Lamdan via charoi Khullen for checking water pipe line (one pipe length 20 feet each & diameter 3 inch) which is lengthening from Lower Kom Keirap via charoi Khullen upto Lamdan village is about 1.5 KM and found there around 100 nos. of pipes (G.I) for conveying water were missing and might be stolen by some unknown persons. The stolen pipes are mostly in between Charoi Khullen and Lamdan village area. The approximate value of the stolen water pipes is Rs. 4,00,000/- (Four Lakhs). The water pipe line is sponsored by PHED (Public Health Engineering Department) Govt. of Manipur under the aegis of Rural Water Supply for providing drinking water to rural area. I cannot report timely as in searched of the stolen water pipes.

Hence, I sincerely request you to kindly take further necessary action as per law.
