Sir,

I have the honour to report that today i.e.26/05/2025 at about 1:30 pm, I along with my team of CDO-BPR assisted by team of CDO Unit Bishnupur led by Hav.no.411811-Thokchom Basanta Singh of 4th IRB attached with CDO Unit Bishnupur and team of Bishnupur PS including the Women police were conducting routine frisking & checking in c/w present law & order situation at Nachou Panthong area under the command of Sub. Y. Shakti Shen Singh, OC-CDO/BPR, P. Sanjoy Singh, MPS, Dy. SP(CDO-I), Bishnupur and under the supervision of Amarjit Singh Lamabam, MPS Addl. SP (Ops) Bishnupur and overall guidance of Ksh. Ravikumar Singh, IPS SP-Bishnupur. conducted regular frisking and checking at Nachou Panthong along Tiddim Road.

During the course of frisking and checking, one Tata Winger which was coming from Moirang side towards Imphal side was intercepted on the spot and on verification of the passengers of the vehicle, one female was seen in a very suspicious and detained her at the spot. On spot verification, she identified herself as Najima (42) W/o (I.) Mohammed Maheruddin of Kwakthi ward no. 6.

Further, as it was required to search the body of the individual thoroughly, option for search memos and option statements were prepared. The contents of the option for search memos and the option statements were translated to her in Manipur dialect. As per her option statement, information has given to P. Sanjoy Singh, MPS, Dy. SP (CDO-I), Bishnupur and rushed to the spot at around 2:05 pm. On searching the individual and her belongings by lady police constable, 13 nos. of soap cases containing suspected to be heroin powder were found from her possession. Further, i) One Cellecor mobile handset having Airtel SIM Card bearing No. 6909163038, ii) One Redmi mobile handset (Redmi Note 10T 5G) having Airtel SIM Cards No. 8413014186 & 9612531700, iii) One Aadhaar Card in the name of Najima having No. 2323-4542-1248 were also found from her possession.

All the 13(Thirteen) nos. of soap cases containing suspected to be Heroin No.4 heroin powder weighing approx. 152 gms (excluding the soap cases and including plastic pouch) and Further i) One Cellecor mobile handset having Airtel SIM Card bearing No. 6909163038, ii) One Redmi mobile handset (Redmi Note 10T 5G) having Airtel SIM Cards No. 8413014186 & 9612531700, iii) One Aadhaar Card in the name of Najima having No. 2323-4542-1248 were seized in presence of gazetted Officer P. Sanjoy Singh, MPS, Dy. SP (CDO-I), Bishnupur by completing all formalities.



All the 13(Thirteen) nos. of soap cases containing suspected No.4 heroin powder weighing approx. 152 gms (excluding plastic soap cases and including weight of plastic pouch) were packed with a white cloth and sealed is marked as "X" in presence of Gazetted Officer, P. Sanjoy Singh, MPS, Dy. Sp(CDO-I), Bishnupur. Accordingly Mrs. Najima (42) W/o (L) Mohammed Maheruddin of Kwakta ward no. 6 was arrested on the spot at 03:05 pm.

Hence, the arrested person along with the seized items are hereby handed over to you for taking further necessary legal action.
