Recently I came to know about the execution of the execution of the Regd.sale dedd and accordingly I made due enquiry and on 07.08.2025 obtained the certified copy of the Regd.sale Deed vide No.480 dtd. 27.04.2021(executed on 13.01.2021), No.479 dtd.27.04.2021(executed on 13.01.2021), and Regd.No.478 dtd.27.04.2021(executed on 13.01.2021) from the office of Sr.Sub Registrar, Silchar, Cachar and found that the above Registered Deeds was executed and registered fraudulently in the name of the below named accused No.1,2,3,4,5 and 6 and the attesting witness of the said Deeds was the accused No.7,8, claiming to purchase the property from me, I was shocked to learn that my signature was forged and my consent was neither sought nor given, I have never appeared before the Sab Registrar for any such transaction.


