I am the honour to report that, my daughter namely Samina (22) has been kidnapped by Md. Nasir S/o. Md Ithem, of Lilong Suktu Karong Sangomshang, PO & PS Lilong and his mother namely Sirabana from Kwakta in a car ( colour not known) on 02/06/2025 at @ 0120 am and kept concealed till date.

The matter comes to light when my daughter call up her sister on 06/06/2025 and informed that she eloped with Md Nasir. The formalities of elopement as per custom are also not performed by the families of the accused persons.

Further, It has come to learnt that the said accused person has kidnapped my daughter and kept concealed till date and her whereabouts are also not known till date.

I could not report In time due to lack of legal knowledge and searching of my daughter . It is therefore requested kindly to take necessary legal action against the accused persons.
