Sub: Complainant against criminal trespass, mischief, physical assault, outraging her modesty and criminal intimidation by Mr. Kangjam Prameshor Singh and his family members.

Respected Madam,

I, Smt. Laishram Nirmala Devi, aged about 34 years, daughter of Laishram Rupachandra Singh, a resident of Yumnam Huidrom Thiyam Leishangkhong, P.O. & P.S. Wangoi, Imphal West District, Manipur most respectfully submit this complaint seeking your kind intervention and immediate legal action against the following individuals.

- 1. Mr. Kangjam Prameshor Meitei, aged about 39 years, S/o. K. Temba Meitei,
- 2. Mrs. Kangjam Echan Devi (wife of Prameshor Singh),
- 3. Mr. Kangjam Sanathoi Singh(younger brother)
- 4. Mr. Kangjam Modhumangol Singh (elder brother)
- 5. Mrs. Kangjam Premila Devi (wife of Modhumangol Singh)

all residents of Kodompokpi Mayai Leikai, Malom Tiluhal, P.O. Tulihal & P.S. Nambol, Imphal West District, Manipur.

- 1. That I am the lawful owner and possessor of a homestead land situated at Kodompokpi Mayai Leikai in a compact block covered by New Patta No. 40/1321 (New) Hiyangthang Tehsil, Wangoi Sub Division, Imphal West District, Manipur measuring of 0.78 acre and 0.66 acre under C.S. Dg Nos. 1115 and 1117 respectively, which is presently under dispute and pending adjudication before the Hon'ble Civil Judge (Senior Division), Imphal West, Manipur. An application for temporary injunction is also pending and the matter is sub-judice.
- 2. That, earlier, a similar incident of criminal trespass had occurred involving the same accused persons, and upon my complaint, the concerned Nambol Police Station had intervened and directed all parties to maintain status quo as well as peace and tranquillity in respect of the said land till the disposal of the injunction hearing.
- 3. However, the accused persons have blatantly violated the direction of NambolPolice Station by again trespassing into the suit land on 05-07-2025 at about 12:00 a.m. and further engaged in illegal and violent actions.
- 4. On the said date, the accused persons forcibly entered into my homestead land and illegally used and excavator (JCB), to dig up and spoil the land, thereby causing substantial damage to the property.
- 5. That, when I tried to stop them, Mr. Kangjam Prameshor Singh and his elder brother Kangjam Modhumangol Singh physically assaulted me by slapping, dragging me by my hair, and using vulgar and abusive language, which amounts to both physical and verbal abuse against a woman. During the act of assault, he also violently grabbed and tore off my upper garments including my shirt and innerwear (bra), causing me extreme physical pain, humiliation, mental trauma. Fingerprints and red marks were visible left just above my breast, clesrly indicating the aggressive and indecent manner of the assault.
- 6. That, due to the reckless and unlawful act of the accused persons, the seasonal vegetables which I had personally cultivated for self-consumption and livelihood were completely uprooted and destroyed by the excavator. Additionally, the barbed wire fencing that I had erected around the homestead land to protect it from encroachment and stray animals was crushed and dismantled during the unauthorized digging. The damage caused is not only physical and financial min nature but also emotional and symbolic, as it reflects a deliberate attempt by the accused persons to undermine my rightful possession and humiliate me.

That, during the course of the incident, Mr. Kangjam Prameshor Singh and Mr. Kangjam Modhumangol Singh resorted to criminal intimidation, verbally abusing and threatening me in the presence of others. They brazenly declared that since the said land is located within their colony and reside far away (at a distance of more than 25 Km), I should not interfere or claim any right over the land. They warned me of dire consequences, including physical harm, if I dared to come near the land again or pursued any legal action. These threats were made a clear intention of instilling fear, suppressing my legal rights, and discouraging me from protecting my property.

8. That, I state with utmost seriousness that the unlawful act of dispossession and violence was carried out while the suit regarding the said land is pending before the Hon'ble Civil Judge (Senior Division), Imphal West, wherein an application for temporary injunction is actively being heard. The actions of the

accused persons, therefore, amount to interference in the due process of law and constitute a clear attempt to overreach the jurisdiction of the civil court by using force instead of waiting for the court's decision. The timing of the act indicates that the accused are trying to change the nature and character of the suit land during pendency of litigation, which is impermissible under the law and is a blatant

violation of the principles of status quo and judicial property.

9. In view of the above facts and circumstances I pray to you that you may kindly be taken action under the relevant provision so as to give befitting punishment to the accused persons.

I shall be grateful for your prompt and just action.
