Sir,

I have the honour to report today i.e. 04/05/2025 at about 3:30 am based on a specific input from 19 AR and corroborated with own source about the movement of some armed militants from hill side and cache of explosives, arms and ammunitions in the fringe area of Samuchep Lok/Nala bordering Bishnupur and Churachandpur District under Loktak-PS, a combine team of Bishnupur District Police led by Shri Chaitanya, IPS(P), i/c Nambol-PS, Inson Md. Abdul Gaffur Masood, OC/LTK-PS and Sub. Y. Shaktishen Singh, OC/CDO-BPR assisted by Hav. Kh. Kunje Singh, a team of Loktak-PS led by assisted by ASI N. Ramaswami Singh of LTK-PS under the command of Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops)/BPR, a column of 5 Sikh Regiment led by Maj. Lokpal and a column of 19 AR led by Maj. Saurabh Bhartari under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SB-BPR conducted cordon and search operation in the said area. Some suspected areas were cordoned from 05:00 am by a team led by Shri Chaitanya, IPS(P), i/c NBL-PS and OC-CDO/BPR with team from the northern side, column of 19 AR and 5th Sikh Regiment from western side and self with my team along with Hav. Kh. Kunje Singh and OC LTK/PS with team from eastern side and search started. In the operation the following arms and explosives items were recovered found concealed with dry leaves and seized from Samuchep Lok/Nala at around 6:00 am. Further the operation was closed at 7:00 am.
