I, the undersigned have the honour to report that in view of the current prevailing Law and Order situation and the upcoming Assembly session, Feb, 2025 as well as to detect any kinds of illegal and snatched weapons, incriminating articles concealed and to sanitize the fringe area properly, today i.e. 09/02/2025 at 2:30 pm under the supervision of Ksh Ravikumar Singh.IPS,SP/BPR and Amarjit Lamabam,MPS, Addl. SP/OPS Bishnupur conducted a join cordon and search operation at the adjoining fringe area between the foot hill of Naodakhong and Sagang by a combined teams comprising of Bishnupur District Police led by D. Robinson (MPS) DSP/CDO-BPR II and Sub.Y. Shaktishen Singh OC/CDO Bpr, including self and assisted by ASI Victor Haobijam, a team of KUB-PS led by SI. M. Prasanta Singh along with a column of 2 Mahar Regt. led by Captain Ajai conducted search operation in the said areas. Some suspected areas were cordoned from 3:00 pm. Then after proper planning and briefing, search party teams were formed and started searching the said suspected areas. During the course of operation, the following arms, ammunitions and explosives were recovered from foot hill between Naodakhong and Sagang.
