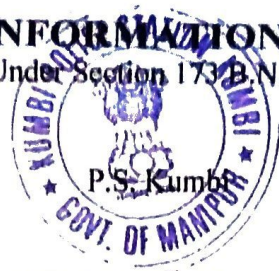

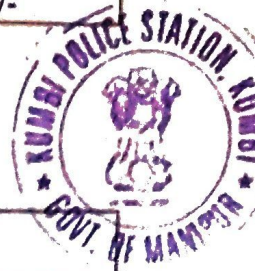

These Criminals broke open my gate (s) and looted every valuable property from my house and premises worth Rupees 8,85,000/- (approx.) and they burnt down all the remaining things. Fortunately, me and my family manage to escape from these criminals who even tried to kill or burnt us alive.

Therefore, with utmost respect I request you to take strong actions against the perpetrators by registering and FIR under relevant sections of the Indian Penal Code.
