Sir,

I have the honour to report that today i.e. 03/07/2025 at 6:00 am, based on reliable information regarding the presence of some armed miscreants at Naodakhong area for carrying out extortion activities from the general public and threatening the localities, accordingly, joint teams of CDO-BPR led by self, a team of Kumbi-PS including lady police led by ASI Kh. Sanayaima Meetei assisted by 01 x column of 2 MAHAR Reg. led by Major Aditya Jain under the command of Sub.Y. Shaktishen Singh OC/CDO-BPR, under the supervision of Shri. Amarjit Singh Lamabam, MPS, Addl. SP (Ops), Bishnupur and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-Bishnupur conducted a cordon and search operation in the said area after giving prior information to the concerned authority.

During the search operation, a highly suspected house was spotted which was found locked from outside. On verification, the owner of the house was identified as one Khangembam Ratan Singh S/o Late Khangembam Meleirangba Singh of Wangoo Naodakhong Makha Leikai. As the house was found locked and the house owner was not contactable, some local independent witnesses including the wife of Khangembam Ratan Singh were called and asked to open the lock with its key. However, the key was not brought by the owner's wife namely Khangembam (O) Ranjana Devi W/o Kh. Ratan Singh of Naodakhong, Ward No. 1, Makha Leikai, and even when they asked other family members, the whereabouts of the key could not be ascertained. On the other hand, the public from the surrounding localities also tried to create an unruly mob to oppose the combined security team.

So, with the full consent of the lady, i.e., the house owner's wife, after convincing her of the arising situation, the lock was broken and a minute house search was conducted by the combined team in the presence of the independent witnesses namely, i) Khangembam (O) Ranjana Devi W/o Kh. Ratan Singh of Wangoo Naodakhong Makha Leikai and ii) Sanasam Dinesh Singh S/o S. Mohon Singh of Wangoo Naodakhong. During the search inside the house, the following arms and ammunition were recovered from one iron Godrej when opened by the lady house owner, but even during the search operation, the house owner still remained untraced.

So, the undernoted arms & ammunition were seized under a formal seizure memo in the presence of the witnesses by maintaining all required formalities at 9:32 am.

Details of the seized items:

1. 01 (One) .32 mm pistol marked as "State property of the Spain Government".
2. 02 (Two) empty magazines marked as "97871" each.
3. 02 (Two) live rounds .32 mm ammunition marked as "KF 7.65".
4. 01 (One) leather handbag, white in colour.

Hence, the above-seized arms and ammunition along with the seizure memo are handed over to you for taking further necessary action.
