I have the honour to report that on 03/05/2023 I along with my family members fled away/ leaving behind my house and valuable household properties due to fear of the communal clash in between Meitei and Kuki and sheltered at a relief camp at Ithai Khunou Govt. High School, Ithai Khunou. While I along with my family members were at the relief camp, On 10/01/2024 at around 3:00 pm suspected to be Kuki militants attacked Haotak Tampha Khunou by using sophisticated weapons and bombs. On 15/01/2024 I along with my family members returned to my house at Haotak Tampha Khunou and on checking my house and roof was found severely damaged/broken by the bombs blasted near my house. Further, on checking valuable house hold properties were also found stolen. The assets/properties damaged/stolen are listed below:-
