Respected Sir,

On 03/05/2023 at @ 7:30 pm, Haotak Gelbung, Vijang etc were attacked and burnt down by a large gathering mob. Due to fear, I along with my family members fled from my house, Haotak Tampha Khunou and sheltered at Mangolganbi College Relief camp. However, on 30/06/2025 at @ 3:00 pm when I along with my family members returned from the Relief Camp, the following properties were found vandalized and stolen by persons.
