Sir



I am to report that today i.e. 19/03/2025 at about 9. 00 am, received a reliable input from 2 MAHAR corroborated from own sources regarding presence of some active members of valley based unlawful organization in and around Sandangkhong area to carried out extortion and threatning to the staffs of government Schools and Colleges. Based on this input, a combined team of CDO-BPR assisted by ASI H. Robash Singh command of Sub. Y. Shaktishen Singh, OC-CDO/BPR along with a column of 2 MAHAR Regiment led by Major Aditya under the supervision of Shri Amarjit Singh Lamabam, MPS, Addl. SP(Ops)/BPR and under the overall guidance of Shri Ksh. Ravikumar Singh, IPS, SP-BPR conducted frisking & checking at Sandangkhong and Sagang area. During frisking one unknown person was detained on suspicion manner at Sandangkhong near bridge. Later, he identified himself as Salam Brojen Singh (47 yrs) S/O Salam Sanamatum Singh of Sagang Bazar Mamang Leikai, an active member of Socialist Revolutionary Party (SOREPA), Kangleipak. On questioning, he disclosed that he is an Ex-Cadre of KCP Taibanganba and arrested thrice before. In the month of September, 2023 he joined to unlawful outfit SOREPA as OGW through one Fighter (50 yrs) of Irengbam Village Bishnupur District now at Myanmar. On body search one VIVO mobile handset along with one Jio Sim Card and one Aadhaar Card were recovered from his possession. Hence he was arrested from the spot at 10:05 am and seized the same items at 10:10 am. On further questioning he revealed that he kept conceal some Demand letter at his house.

On follow up action the combined team rushed to the house of the individual residence at Sagang and recovered 8(eight) nos. of demand letter in the name of Socialist Revolutionary Party(SOREPA), Kangleipak in 8(eight) different brown colour paper envelope and a list of 38 nos. of School of Bishnupur District on production by the arrestee Salam Brojen Singh (47 yrs) and same has been seized at 10:23 am by observing formalities.

The arrestee and the seized items are handed over to you for taking further necessary legal action.
