Subject: - Report.



Sir,

I have the honour to state that yesterday i.e. 14/09/2025 at around 12:25 pm, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of NRFM organization (a faction of KCP organization), an outlawed banned organization in and around Keirao area of Imphal East District with a view to commit prejudicial activities like extortion of money from shops and general public etc. Based on the information and with the permission/authorization of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy. SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Keirao Bitra Awang Leikai area. During that one suspected person was detained at Keirao Bitra Awang Leikai. During spot verification, the detainee identified himself as Ningthoujam Yamba Singh (44 yrs.) @ Boy @ Sanayamba S/o. (L) N. Deben Singh of Keirao Bitra Awang Leikai, Imphal East District, Manipur.

During preliminary verification, he disclosed that he is an active member of NRFM organization (a faction of KCP organization) and started working for the said organization since August, 2025 through one s/s Finance Secretary Nongpoknganba (Ph. No. 7085538357) of NRFM organization who is presently staying in Bangladesh. He also disclosed that under the instruction of his commander Nongpoknganba (the above mentioned), he was involved in extortion activities by serving monetary demands/threats to general public in valley area for raising their party fund.

Hence, he was arrested from the spot i.e., at Keirao Bitra Awang Leikai at 03:02 pm by observing necessary formalities.

From his possession, (i) one POCO M4 5G mobile handset along with one Airtel SIM card bearing mobile no. 8119966495 (as disclosed by him) was seized at the spot at 03:09 pm by observing due formalities.

On thorough verification, the arrestee disclosed that he used a Nokia keypad mobile handset along with one Airtel SIM card bearing mobile no. 8974916307 in extortion activities and the same mobile handset along with the said Airtel SIM card was handed over to his associate namely one Naresh from Singjamei Wangma Kshetri Leikai area who also possessed a pistol.

Immediately, our CDO-IW team along with the arrestee rushed to Singjamei Wangma Kshetri Leikai area and conducted search operation at the said area. During that, as pointed out by the arrestee, the above mentioned associate Naresh along with another associate were detained at Singjamei Wangma Kshetri Leikai who later identified themselves as (i) Nongmeikapam Naresh Meitei (38 yrs.) S/o. (L) Nongmeikapam Joy Meitei of Singjamei Wangma Kshetri Leikai, Imphal East District, Manipur and (ii) Yumnam Tejkumar Singh (48 yrs.) @ Bobo S/o. (L) Y. Tathot Singh of Singjamei Wangma Kshetri Leikai, Imphal East District, Manipur respectively. On asking about the detainees, the arrestee Ningthoujam Yamba Singh disclosed that both of them are his associates who are presently working under his command.

On spot verification, Nongmeikapam Naresh Meitei disclosed that he kept one pistol in the house of his associate namely one Nilakanta of Singjamei Wangma Kshetri Leikai Mongkhang Lambi for the purpose of committing prejudicial activities.

Immediately, our CDO-IW team along with the arrestee and the above mentioned detainees namely Nongmeikapam Naresh Meitei and Yumnam Tejkumar Singh rushed to the house of Nilakanta located at Singjamei Wangma Kshetri Leikai Mongkhang Lambi after giving prior information to Imphal East District Police Control Room whereas Nilakanta was not found in his house and as pointed out by Nongmeikapam Naresh Meitei, one side bag black in colour containing one .32 pistol marked with "MADE IN ISRAEL" along with one magazine loaded with 3 (three) rounds of 7.65 mm ammunition was recovered from the bedroom of one Laishram Nilakanta Singh (aged about 44 yrs.) S/o. L. Itobi Singh of Singjamei Wangma Kshetri Leikai Mongkhang Lambi, Imphal East District, Manipur.

On asking about the above mentioned Nokia keypad mobile handset, Nongmeikapam Naresh Meitei disclosed that the said Nokia keypad mobile handset was used by the above mentioned arrestee Ningthoujam Yamba Singh in extortion activities and the same Nokia keypad mobile handset was possessed by his associate namely Yumnam Tejkumar Singh (the above mentioned detainee). From the possession of Yumnam Tejkumar Singh, the said Nokia keypad mobile handset along with one Airtel SIM card bearing mobile no. 8974916307 was recovered.

Hence, Nongmeikapam Naresh Meitei and Yumnam Tejkumar Singh were arrested at the spot i.e., at the house of Laishram Nilakanta Singh located at Singjamei Wangma Kshetri Leikai Mongkhang Lambi at 09:39 pm and 09:44 pm respectively by observing necessary formalities.

From the possession of Nongmeikapam Naresh Meitei, the following recovered items were seized at the spot by observing formalities at 09:50 pm: (i) the above recovered side bag containing illegal arm and ammunitions, (ii) one Samsung Galaxy A53 5G mobile handset along with one Jio SIM card bearing mobile no. 6009197614 (as disclosed by him) and (iii) one wallet black in colour containing one Aadhaar card bearing no. 4044 5318 1641.

Further, from the possession of Yumnam Tejkumar Singh, the following recovered items were seized at the spot by observing formalities at 09:53 pm: (i) the above recovered Nokia keypad mobile handset and (ii) one Redmi 5G mobile handset along with one Airtel SIM card bearing mobile no. 7085350969 (as disclosed by him).

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
