I have the honour to report that yesterday i.e. 04/10/2025 at about 02:00 pm, while my wife namely Keisham Lakshmibai Devi, aged about 51, was in her grocery shop at Kongba Nandeibam Leikai, on the western side of Leirak No. 5, was attacked with an iron rod by Pangambam Manindra (35), s/o (L) P. Yaima Singh, r/o Kongba Nandeibam Leikai, on her head. In that, she suffered injuries on her head and evacuated at JNIMS Hospital, Porompat, where she was treated with stiches on her head and other serious investigations like CT scan, etc. The matter could not be reported in time as we were busy with her treatment.

It is, therefore, requested to kindly take necessary legal actions against him for the ends of justice.
