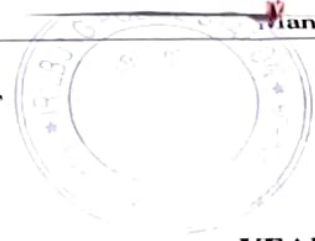

Subject: - Report.

Sir,

I have the honour to state that today i.e. 08/10/2025 at about 02:10 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of RPF/PLA organization, an outlawed banned organization, in and around Arapti Mayai Leikai of Imphal East District with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri K. Dineshkumar Singh, MPS, Dy. SP (CDO), IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area after giving prior information to Imphal East District Police Control Room and conducted search operation at Arapti Mayai Leikai area. During that one suspected person was detained at a house located at Arapti Mayai Leikai. During spot verification, the detainee identified himself as Mayanglambam Milan Singh (39 yrs) @ Lalhaba S/o. M. Bihari Singh of Arapti Mayai Leikai, Imphal East District, Manipur (who later identified himself as the resident of the said house).

During preliminary verification, he disclosed that he is an active cadre of RPF/PLA organization and joined the said organization in April, 2022 through one Lucky of RPF/PLA organization from Moreh area and got Basic Military Training for 04 (four) months in Mutthein, Myanmar and was allotted Army No. 3341 of 2022 and he is presently holding the rank of s/s Private of RPF/PLA organization. He also disclosed that he was involved in extortion and kidnapping for ransom activities in valley area for raising their party fund.

Hence, he was arrested from the spot i.e., from his residence at 04:20 am by observing formalities.

Further, from his possession, one Redmi A5 mobile handset along with one Airtel SIM card bearing mobile no. 8413098619 (as disclosed by him) was seized at the spot at 04:26 am by observing due formalities.

Hence, the arrested person and the seized article are handed over to you for taking further necessary legal action against him.
