Subject: REQUISITION TO LODGE AN FIR AGAINST SIX UKNA CADRES. OP SONHGKOT – 36 Assam Rifles: 01 Oct 2025

Sir,

With due respect, I would like to state that After the major breakthrough achieved in February 2025 with the apprehension of Seiminlen Doungel, Finance Secretary of the proscribed United Kuki National Army (UKNA) a NON-SoO group, 36 Assam rifles gained signification edge against insurgent networks. His interrogation, along with subsequent captures of UKNA cadres namely SS 2nd Lt Phillips in Apr 25, yielded critical intelligence on SS Lt Jamkhogin Guite Lupho alias Pepsi, a senior UKNA Cadre who has been involved in Various illegal activities including killing and sabotage. These leads. Corroborated by inputs from HUMINT and technical intercepts from TECHINT, confirmed his involvement in high level activities for UKNA.

Details about Lt Jamkhogin Guite Lupho alias Pepsi

- 1.2.1 SS Lt Jamkhogin Guite Lupho allas Pepsi is senior cadre of UKNA and was involved in executing targeted attacks. Sabotage activities and killings on behalf of UKNA. His special involvement in major cases are given in subsequent paragraphs.
- 1.2.2 Attack on CM'S Convoy in Jiribam on 10 June 2024. SS Lt Jamkhogin was the main accused in planning and executing attack on CM;s convoy in Jiribam along with other cadres.
- 1.2.3 Recent ambush on KNA SS Deputy Commander –in-Chief Thenthang alias Thahpi in July 2025 was planned and executed by him.
- 1.2.4 His action include killing of three Meltel Woodcutters at Haotak Khollen, Churachandpur in 2024, Killing of Meitei civilian in Songdo area in Churachandpur in 2024.
- 1.2.5 He along with his associates carried out planned ambush on 30 Assam Rifles convey in Jiribam.
- 1.2.6 He was involved in blowing of electric tower in KPI in 2023.
- 1.2.7 He was also singlehandedly executing attack on petrol tanker in Jiribam in 2024.
- 1.3. Surveillance & Tracking. Post the apprehension of Seiminlen Dioungel in Feb 25, his contact No. was identified involved in various arms deal & extortion activities on behalf of UKNA. Latrer during Op Bethel on 02 Mar 2025, four HNA cadres were apprehended who revealed that they were working under SS Lt Jamkhogin. Other contact No.s were also identified and put under surveillance however, he kept changing his Nos During Op D Vaison when SS 2nd Lt Thangminlun Haokip was apprehended. He revealed that SS Lt Jamkhogin has left the Churachandpur District being concerned on arrest by security force. No contact number of him was and his active and his input of moving to Jiribam was received. On 02 Sept 2025, during Op B Kalzang, SS Corporal Henminlung alias Jonathan was apprehended who revealed that SS Lt Jamkhogin has

come back and is active general area Henglep & Suangsong. His mobile No was also identified being in use multiple occasions.

1.4 Operation Launch:

- 1.4.1. on 30 Sep 2025. Input received that SS Lt Jamkhogin along with other UKNA cadres have come to Henglep to be part of the deal with CKMA Commander-in-Chief Paolen Guite. He was instrumental in finalizing the same arms deal and area distribution between UKNA and CKMA. Post the arrest of Paolen Guite on night 30 Sept 2025, SS Lt. Jamkhogin became wary of his arrest and moved from his hideout in fringe areas.
- 14.2. His location was identified using TECHINT & HUMINT and his move pattern discerned going towards Henglep & Suangsong to his safe havens.
- 1.4.3. Multiple ambushes were launched from S.Kholen and Aina to intercept and apprehend these cadres.
- 14.4. At 1900 hours, 01 Oct 25, inputs were received through own sources that SS Lt. Jamkhogin is approaching general areas Songkot and moving towards Henglep. Ambushes were readjusted to track him down. Simultaneously, a column of 00-01-20 under Nb. Sub. Khushi Ram was swiftly launched from COB S.Kholen at 1900 hours on 01 Oct 25 carefully timed to achieve the twin advantages of surprise and night dominance. Through meticulous planning and tactical brilliance, the party established multiple opportunity ambushes at a tactically advantageous location, leaving no route for escape in general area Songkot (14 km NE of COB S.Kholen).
- 1.4.5. Upon reaching the pre-planned location, the cadres were caught completely off guard. Confronted by the sudden presence of SFs, they attempted to disperse and flee in multiple directions. The party commander immediately relayed via Motorola that two cadres have escaped from their side. Reacting without hesitation, the column second in command with his quick reaction team penetrated deep into the dense forest, pursuing the fleeing cadres for approx. 700 meters, ultimately apprehending both the cadres and leaving them with no avenue of escape.
- 1.4.6. Simultaneously, four additional suspected cadres, including SS Lt. Jamkhogin alias Pepsi, in a desperate attempt to evade capture, jumped off the roadside and sought refuge in the dense jungle under the cover of darkness. The alert soldiers, under the leadership of column commander, swiftly initiated pursuit. Over the course of nearly 1000 meters, they navigated through thick undergrowth, uneven slopes and challenging terrain in pitch-dark conditions. Demonstration exceptional endurance, tactical acumen and unwavering determination, the soldiers gradually tightened the cordon around the fleeing cadres.
- 1.4.7. SS Lt. Jamkhogin faced with overwhelming pressure and the unrelenting presence of security forces, attempted to fire to prevent escape, however, column commander dived on top of him and physically overpowered him after physical scuffle and apprehended him. Other three cadres were cornered by the Quick Reaction Team and apprehended them.
- 1.4.8. The operation concluded successfully with the apprehension of six cadres at 0100 hours on 02 Oct 2025 namely SS Lt. Jamkhogin Guite Lupho alias Pepsi, Lunkholen Singson, Paolenlal Kipgen, Kamgoulen alias Gous, Thangzasuan and Khaiginpao. This meticulously executed operation highlights the high level of coordination, vigilance and operational excellence displayed by the soldiers in challenging conditions.
- 1.5. Impact of the Operation.
- ·1.5.1. Disruption in Extortion & Arming of UKNA Group.



- SS Lt. Jamkhogin was instrumental in managing the finance through extortion and arms deal in collaborat with CKMA Chief Paolen Guite. His arrest will significantly disrupt the extortion activities and arming
- 1.5.2. Dent to UKNA Group. The aiming of Non SoO Groups incl UKNA will be curtailed, thereby limiting t
- 1.5.3. UKNA Destabilization. UKNA's operations will be adversely affected since he was instrumental planning, coordination and execution of UKNA's operation not only in Churachandpur but also in Jiribam.
- 1.5.4. Illegal Arms & Financial Network. His arrest will reveal potential arms & financial networks active Manipur that funds insurgency and weapons trafficking. This will be a major blow to the insurgent networ
