Today, i.e 11/09/2025 at about 05:53 am, received an verbal report from the unknown person that, one unidentified dead body was found lying on the road side in between S. Zezaw Village and S. Geltui Village, Singngat Sub-division boundary along Teddim Road. On received of the report, self along with Police party immediately rushed to the spot for enquiry. On arrival at the spot, inspected the crime scene very thoroughly and minutely and the cause of death is highly suspected to be a Hit and Run case (suspected to be heavy vehicle). An inquest was conducted a the spot and the scene of crfime was photographed. After enquiring the deceased person was identified as Mr. Pauzamuan Ngaihte (29) s/o H. Henzakhup Ngaihte of S. Munpi Village, Singngat Sub-division, CCP. After completion of all formalities, the dead body was deposited at District Hospital Morgue, CCP for Post-Mortem and further investigation. Hence a suo-motto case under FIR no. 08(09) 2025 SGT-PS u/s 281/106(1) BNS is registered for investigation.
