Sir,

I have the honour to state that today ie. 29/09/2025 at about 11:25 am, a reliable information was received from our own source and further corroborated from the information input provided by 33 AR regarding the presence of some active cadres of KYKL organization, an outlawed banned organization, in and around Paona Bazar area with a view to commit prejudicial activities like extortion of money from the shops and general public etc. Based on the information and with the permission/authorization of the authority, a team of CDO-IW led by Inspector Gunachandra Chanam. OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, Addl. SP(Ops.)/IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at some places of Paona Bazar area. During that one suspected person was detained at Paona Bazar near Pratap Hall. During spot verification, the detainee identified himself as Urikhinbam Premjit Singh (41 yrs) S/o. (L) U. Ibomcha Singh of Lamjao Mayai Leikai, Kakching District, Manipur.

During preliminary verification, he disclosed that he is an active member of KYKL organization and started working for the said organization since October, 2024 through one Thouba@ Wanglen Sintha of KYKL organization from Wabagai area who is presently staying in Delhi. On further verification, he disclosed that he is presently working under the command of the above mentioned s/s Commander Thouba@ Wanglen@ Sintha (Ph. No. 6909225545) who is also working as s/s District Finance of Imphal West District of KYKL organization. He also disclosed that under the instruction of his commander, he was involved in extortion activities by serving monetary demands/threats by using demand letters of KYKL organization and collected money from shops and general public in valley area including Paona Bazar and Thangal Bazar area and the extorted money were handed over to his commander as their party fund.

Hence, he was arrested from the spot i.e., at Paona Bazar near Pratap Hall at 01:04 pm by observing formalities.

Further, from his possession: (i) one OPPO A53 mobile handset along with one Jio SIM card bearing mobile no. 9366280852 (as disclosed by him) and (ii) one black side bag containing a sum of Rs. 3,280/- (Rupces three thousand two hundred and eighty only) were seized at the spot at 01:10 pm by observing due formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.
