Vengnom submits this complaint seeking registration of a case against a Whatsapp channel operating under the name "BEHIND THE TRUTH" said channel has disseminated unverified, fabricated and defamatory imputations alleging that the elected Member of Legislative Assembly from Henglep Constituency has clandestinely formed an armed organization styled as the United Kuki National Army.

The said channel is not only engaged in circulating such false and malicious allegations but has, on multiple occasions, been accused of habitually spewing hatred within communities in the town, thereby aggravating tensions, sowing division, and disturbing communal harmony. The present act is therefore not an isolated occurrence but part of a sustained pattern of conduct intended to mislead the public and discredit democratic institutions.

Such imputations, devoid of any factual foundation, are manifestly malicious and calculated to injure the reputation of the concerned public representative while simultaneously provoking unrest, disturbing public tranquility, and fomenting communal disharmony. The nature of the allegations, their mode of publication, and the platform chosen for circulation indicate a deliberate design to create mistrust amongst communities and destabilize the peace of the region.

The acts complained of clearly disclose commission of cognizable offences under the Bharatiya Nyaya Sanhita, 2023, including section 115(promotion of enmity between groups), section 353 (statements conducing to public mischief), section 356 (defamation), and section 66D IT Acts (Cheating by personation using computer resources). 


