



Subject :- Report.

Sir,

I have the honour to report that today i.e. 30/09/2025 at about 05:55 p.m. received a reliable information that some vehicle lifter were loitering in and around Phoudel area. On receiving the information, a joint team of Commando Unit Thoubal led by Shri K. Nitaranjan Singh Office-in-charge, Commando Unit Thoubal under the supervision of Shri. Hijam Devendra Singh, MPS, Addl. Superintendent of Police(Ops) Thoubal and under the overall supervision of Shivanand Surve, IPS, Superintendent of Police Thoubal District rushed to the Phoudel area at around 06:30 p.m. and conducted frisking and checking of suspected persons. In that, one unknown person was found person with one Royal Enfield in a very suspicious manner. Upon seeing the our party, the rider attempted to evade the police, lost control, dropped the bike, and was subsequently apprehended and detained for spot verification.

On preliminary verification, he identified himself as Phundreimayum Dawad Khan 24 yrs. S/o. (L) Ph. Rafijuddin of Sangaiyumpham Part-I, Puleipokpi Salam Macha a gang member of vehicle lifter. Further he disclosed that he, in association with one Md. Rakesh of Phoudel, allegedly lifted a Royal Enfield Classic 350 bearing registration Nil from Luwangsangbam near Liberal College, Imphal East District on 29/09/2025.

Hence, he was arrested at 07:00 p.m. of 30/09/2025 from Phoudel Oil pump and seized the above mentioned Royal Enfield Classic 350 bearing registration number Nil, red in colour at 07:20 p.m. of the same day at DHQ by observing formalities.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as some public organized a mob to obstruct the seizure of the above vehicle and to set free the accused person.

The arrested person along with the seized Royal Enfield Classic 350 is handed over to you for taking further necessary legal action against him.
