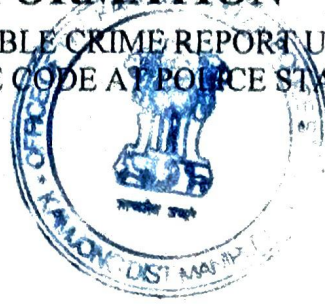

**SUBJ: REPORT**

1. Based on reliable inputs received through own sources regarding move of Manipuri group cadres from Myanmar and their attempt to infiltrate from Myanmar into own territory through Gen area Namlee mkt, an operation was planned to intercept and apprehend the infiltration cadres. Multiple MVCPs/ambush columns were launched on foot tracks coming from Myanmar towards Namlee mkt to intercept the infiltrating cadres.
2. On 13 Feb 2024 at around 1130 hrs, the column at Namlee mkt intercepted move of an injured, suspected individual from Myanmar towards Namlee Police Market.
3. Upon questioning the mov of the suspected individual from Myanmar towards Namlee could not be justified. The suspected individual was apprehended at 1150 hrs and was brought to COB Kasong for details questioning during which he revealed that he belonged to the proscribed insurgent group UNLF (K), bearing Army No – 3302 of 2022 Batch.
4. Details of apprehended individuals is **L Rishikanta Singh aged 18 yrs s/o L Kanhai Singh r/o Naraseina, Bishnupur, Manipur.**
5. You are requested to lodge an FIR in this regard and book the individual as per the requisite law.
