Subject: - Report.

Sir,

I have the honour to state that today i.e. 13/08/2025 at about 06:00 pm, a reliable information was received from our own source regarding the presence of some miscreants who were involved in threatening general public in and around Thangal Bazar area. Based on the information, a team of CDO-IW led by Inspector Gunachandra Chanam, OC-CDO-IW and myself under the command of Shri. P. Achouba Meetei, MPS, Dy.SP(CDO)IW and under the supervision of Shri. Gaurav Dogra, IPS, i/c Addl. SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted search operation at some suspected places of Thangal Bazar area. During that one suspected person was detained near Hotel Yaisana, MG Avenue, Thangal Bazar and from his possession, the following articles were recovered:

(i) one .45 pistol bearing no. IN MSD 23 A1 002687 .45 by MALHOTRASONS DEFENCE along with one magazine, one extra long magazine and 21 (twenty one) rounds of .45 ammunition,

(ii) one pistol holster black in colour bearing no. 1911,

(iii) one gun licence bearing Licence No. (MHA) 22422A7ABEE24 (suspected to be a fake/forged gun licence)

(iv) one Redmi 12 5G mobile handset along with two Jio SIM cards bearing mobile nos. (a) 7005529714 and (b) 7409201614 (as disclosed by him) and

(v) one black side bag.

On spot verification, the detainee identified himself as Sairem Saxena Meetei (33 yrs.) @ Athoiba s/o S. Arunkumar Meetei of Khurai Puthiba Leikai Arambam Leirak, Imphal East District.

During preliminary verification, he disclosed that he is an active cadre of UNLF (P) organization (a faction of UNLF organization) and joined UNLF organization in the year 2007 and got Basic Military Training in Myanmar and was allotted MPA No. 2227 and he is presently holding the rank of s/s Corporal of UNLF (P) organization.

On thorough verification, he disclosed that he was involved in threatening general public at Thangal Bazar area by using the above recovered pistol.

Further, he also disclosed that he was arrested earlier for being involved in arm firing incident at Khuyathong area, which refers to FIR No. 6(1)2024 City-PS u/s 121/121-A/307/506 IPC, 13/20 UA(P) Act & 27(2) Arms Act.

Hence, he was arrested from the spot i.e., near Hotel Yaisana, MG Avenue, Thangal Bazar at 06:20 pm and the above recovered articles were seized at the spot at 06:28 pm by observing necessary formalities.

Hence, the arrested person and the seized articles are handed over to you for taking further necessary legal action against him.


