Sir,



With due respect, I the undersigned would like to state the following facts and circumstances for your kind perusal and necessary action.

- 1. That, I am President of the Unemployed Youth Shop Owner's Association having Regd. No. 104/IW/SR/2000 as such, a dispute occurred between some shop keepers in Khwairamband Bazar Temporary market Ngari Dukan, and when the matter reach before the Hon'ble High Court of Manipur on 03/06/2016 the Hon'ble High Court of Manipur passed in WP(C) no. 529 of 2016 a consensus order between the parties whereby the petitioners shall be allowed to continue the 5 (Five) stalls already allotted to them and the remaining 6 (six) stalls shall be divided 50/50 amongst the petitioners and private respondents No. 5 to 13. The six stalls that are to be divided 50/50 amongst the petitioners as well as respondent No. 5 to 13 as such, the same was disposed of directing the respondent No. 1 & 2 to take steps in terms of the directions of the Court within a period of 2 (two) months, and the wrong allotment order No. IMC/25/RO/Court Order (Pt) Dated 4th July, 2015 given to the respondent was set aside.  - 2. That, further being aggrieved of the non-compliance of the order dated 03/06/2016 passed in WP(C) No. 529 of 2016, the undersigned file a contempt petition being Contempt Case (C) No. 5 of 2023 and the same is pending for compliance till date.
 - 3. That, in the meanwhile, in compliance of the order dated 03/06/2016 passed in WP(C) No. 529 of 2016 and Contempt Case (C) No. 5 of 2023, the SDO, Lamphel, Imphal West serving due summon to parties dated 2nd January. 2025 after giving an opportunity and hearing both parties have been conducted thereafter an eviction notice dated 21/04/2025 to vacate the concerned shops illegally possessed by 3.00 p.m. dtd. 02/05/2025. (copy enclosed)
 - 4. That, it is also pertinent to submit that the encroacher had filed W.P.(C) No. 361 of 2025 challenging the eviction notice dtd. 21/04/2025 and on 02/05/2025 an order was passed by the Hon'ble High Court of Manipur to maintained status quo. However, on 06/05/2025 the Hon'ble High Court was inclined to not extend the interim order for maintaining status quo. Hence, the said interim order granted by the Court on 02/05/2025 was not extended by the order dtd. 06/05/2025. (Copy enclosed)
 - That, eviction order was issued on 08/05/2025, and the eviction was conducted on 14/05/2025 and left the door locked of the concerned shop for eviction, thereafter, the concerned shop owners also put their signatures for handing over and taking over, however, the concerned shop owners i.e. Shop No. 4 to 10A. (Copy enclosed)

6. That, with utter shock and surprised, the said shop owners/ occupier have destroyed the locked and started transacting business on day to day basis till date, hence, the same action is liable under BNS Act, 2023 and other relevant provisions of law for criminal trespass, unlawful assembly and cheating against aforesaid Hon'ble Court order and Eviction order.

In view of the factum narrated above, I the undersigned implore your good office for your kind perusal and to take necessary legal action under BNS Act, 2023 and other relevant provisions of law for criminal trespass, unlawful assembly and cheating against aforesaid Hon'ble Court order and Eviction order for the Ends of Justice.
