Subject: A Complaint requesting to take necessary actions against and to file a FIR against Gagandeep Singh, son of Late Sarabjeet Singh of Thangal bazar, Dedi Electricals Building 2<sup>nd</sup> Floor Now Gagan Electricals and his concubine namely Kshetrimayum Sarjulata Devi of Thangal Bazar Dedi Electricals Building 2<sup>nd</sup> Floor who are the accused persons.

Dear Sir,

I would like to state that I am a resident of Thangal Bazar, opposite UCO Bank and I am filing this complaint against my husband, Gagandeep Singh, son of Late Sarabjeet Singh of Thangal bazar, Gagan Electricals and his concubine namely Kshetrimayum Sarjulata Devi of Thangal Bazar Dedi Electricals Building 2nd Floor.

On 23rd August, 2025, my elder daughter namely, Kashish Kaur Bedi was bitten by the dog (Rottweiler) owned by my husband and his concubine when my daughter was going out for attending the tuition. My daughter was seriously injured on body and specially on the back side of the head portion, (The photocopy of the injury is attached). And the total amount of Rs. 31,720/- was spent for the purpose of Medical treatment including the OT. As such my daughter has been injured and she has been traumatized.

It is also pertinent to mention that I have filed a domestic violence case against Gagandeep before the Court of Judicial Magistrate First Class Imphal West bearing **Cril. (DV) Case No. 13/2022** and the same has pending before the Court. And during the case, on 14<sup>th</sup> December, 2023, I was bitten by the same dog on my right while I was trying to protect by younger daughter. And as such an application being Cril. Misc. Case No. 18/2024 was filed and disposed on 29th February, 2024 mentioning that my husband had removed the said dog from the way. (A copy of the order dated 29th February, 2024 declared by the Court of the Judicial Magistrate First Class, Imphal West-I is attached).

They have violated the said order and when requested to remove the dog they didn't listen to me. And even mockingly gesture the dog to bite me and my daughters. Now our lives are in danger to move out from my house.

So, I request Your Goodself be pleased to book the said accused persons under Section 118, 351 and 291 of the BNS.


