Sir,

I have the honour to report that today i.e. the 24<sup>th</sup> September, 2025 at about 2:00 pm received a reliable information from our own source about the presence of an active member of the outfit PREPAK at Paona Bazar and its surrounding area of Imphal-West District. Based on the said information and with the permission/authorization of the authority, teams of conducted a CI. Ops at the said area under the command of Shri. Khumanthem Dhiraj Karan MPS Dy. SP(Ops)IE also looking after the charge of OC-CDO/IE Unit and under the supervision of Shri. Y Joyraj Singh, MPS Addl. SP(Ops)IE at 2:40 p.m. after providing prior information to Imphal-West District Police

In that, one unknown suspicious person was detained for spot verification and checking at Paona Bazar near BT Park, Imphal West District. On checking the detainee body, one sling bag containing one wallet and one mobile phone were found and recovered from his possession. On verification, the detainee identified himself as one Naorem Abinash Singh (19 years) S/o-N. Amarjit Singh of Kakching Sumak Leikai, Naodam Bazar. Kakching PS, Kakching District A/P Ghari Mayai Leikai, Imphal West District. On further verification, the detainee stated that he is an active member of the outfit PREPAK joined through one Mr. Nobin @ Chandra of PREPAK in the month of May, 2025 and presently working under his command.

On further verification, the detainee stated that he had extorted money from various area of Imphal and Kakching District for raising their party fund. He further stated that, today on the advice of the said Mr. Nobin @ Chandra of PREPAK, he had extorted a sum of Rs 5000/- (five thousands rupees) from one unknown person at Kaching area and hand over the same to the said Mr. Nobin @ Chandra of PREPAK

So, the detainee was arrested from the spot i.e. Paona Bazar near BT Park, Imphal West District at 3:15 p.m. and seized. (i) one mobile phone (Oneplus Nord CE Lite 5G) bearing IMEI no. 863809078730652 & 863809078730645 along with one Airtel SIM card having no. +91 9362778155, (ii) one Sling bag black in colour, and (iii) one Wallet containing a sum of Rs. 550/- (five hundred fifty rupees) at the spot i.e. Paona Bazar near BT Park, Imphal West District at 3:20 p.m. from his possession by observing due formalities

Therefore, the arrested person along with the seized items are being handed over to you for taking up further necessary legal actions against him.
