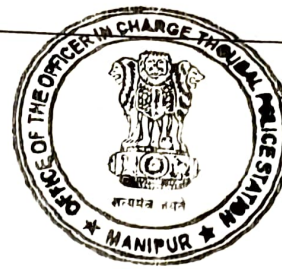

Sir,

With due respect, I the undersigned have the honour to report an incident that occurred yesterday i.e. 14/09/2025 at around 1.30 pm at Lamding Elangbam Leikai, Thoubal near the entrance gate of my house. That, I along with my wife namely Nongmaithem Anuradha Devi aged about 27 yrs W/o Thokchom Deiyabanta Singh and my cousin brother namely Thokchom Telen Singh aged about 23 yrs S/o of Th. Jagat Singh of Lamding Elangbam Leikai, Thoubal while trying to prevent the waterlogging at our Courtyard and evacuating water through the drainage. The undernoted accused started pelting stone towards our house thereby caused a commotion between us. Following the incident we were physically assaulted by the undernoted individuals using sticks and spade after a heated argument. As a result of which we received injury on our bodies including leg, face, hand, head etc. and received medical treatment at Swiss Hospital, Wangjing, Thoubal.

Base on the above facts and circumstances your goodself is therefore requested to take necessary legal action in this regard.
