Sir,

With due respect, I the undersigned have the honour to report and incident that occurred on 14/09/2025 at around 1.30 pm at Lamding Elangbam Leikai, Thoubal. That, when I came back from Hospital, one of my neighbor namely Thokchom Jiban aged about (65) yrs S/o (L) Th. Lala Singh have evacuated water from his house towards our house. Upon seeing that, my elder brother namely Elangbam Mangol Singh (70) yrs S/o (L) E. Mangi Singh of Lamding Elangbam Leikai, Thoubal requested him to stop his act as there will be a ritual ceremony (Usop) on 15/09/2025 at our house, as such act may disturb or cause inconvenient for the said ritual ceremony.

That, rather bringing a settlement, a commotion had occurred with them resulting in an altercation. Following the altercation my brother namely Elangbam Joy Singh aged about (57) yrs S/o (L) E. Mangi Singh including his two sons namely Elangbam Gandhi Singh aged about 31 yrs, Elangbam Govindash Singh aged about 30 yrs and his daughter namely Elangbam Ambika Devi aged about 27 yrs all residence of Lamding Elangbam Leikai, Thoubal who were present during the incident were physically assaulted by the following accused persons without giving a valid approper reason. As a result of it they received injury on their persons and later taken to District Hospital Thoubal for medical treatment. The report was unable to submit on time as we were not legally aware of it.

It is therefore requested to take necessary legal action in this regard.
