With due respect, I the undersigned have the honour to report an incident that occurred on 22/08/2025 at around 12.30 am at Sangaiyumpham Part-I Yangbi Leikai, Moijingmayum, Thoubal. That, when I along with my parents coming back from RIMS Hospital, one Md. Mohammad Khan @ Apik (40) yrs S/o Md. Jalaruddin of Sangaiyumpham Part-I Yangbi Leikai, Moijingmayum who was already lurking at my Courtyard had suddenly stop me and stabbed using a small knife at my left side Jaw line near the left ear without saying any word and the reason for such act is still unknown to me. Further more he threaten that, my family will be killed in any near future. Accordingly, I received medical treatment at District Hospital, Thoubal (enclosed medical certificate) and further undergone medical treatment at RAJ Medicity Hospital, Imphal. I could not report on time due to medical treatment and my family members were also attained at Hospital during treatment.

It is, therefore, rquested to kindly take up necessary legal action against the above person.
