Today i.e. 28/9/2025 at 8:10 pm, received an information that on the same day at about 8 pm, a head on collision road traffic accident occurred at Thoubal Kshetrileikai near Kshetrileikai High School along Thoubal Yairipok Road in between one Tata 407 truck bearing regn. no. MZ05A1914 proceeding from Thoubal towards Yairipok side and one Bajaj Diesel Auto bearing regn. no. MN01Y2894 which was proceeding in the opposite direction due to rash or negligent driving on the part of unknown drivers of the said two vehicles. As a result, unknown driver of the said Diesel Auto and its five unknown occupants sustained injuries and evacuated to the Hospital for medical treatment as well as both vehicles were also partly damaged.
