I have the honour to report that today i.e. 01/10/2025 at about 04:30 a.m. received Sir. I nave the flow that some vehicle lifter were detained by public of Wangjing a reliable information that some vehicle lifter were detained by public of Wangjing a reliable information, a joint team of Sorokhaibam Leikai (SK Leikai) area. On receiving the information, a joint team of Soroknaidani Edina Oraknaidani Lomando Unit Thoubal led by Shri K. Nitaranjan Singh Office-in-charge, Commando Unit Thoubal and a team of Thoubal Police Station under the supervision of Shri. Hijam Devendra Singh, MPS, Addl. Superintendent of Police(Ops) Thoubal and under the overall supervision of Shivanand Surve, IPS, Superintendent of Police Thoubal District rushed to the said area at around 04:50 a.m. and found two individuals were found detained by general public of the area.

On preliminary verification of the two individuals at the spot, they identified themselves as Makakmayum Anisur 23 yrs. S/o. Mk. Majibur of Lilong Lou Tara and Bogimayum Mirja 25 yrs. S/o. BM. Abdul Hakim of Lilong Awang Leikai a gang members of vehicle lifter. Further they disclosed that they had allegedly lifted a TVS Ntorq 125 and kept concealed some distance away from the spot. Accordingly, the said vehicle i,e. a TVS Ntorg 125 bearing registration No. MN01AQ 0628 black in colour was found from the instance of the accused persons. However, at the meantime the local people started forming an unruly mob to attack the two individuals.

For the safety of the accused persons and to prevent from any untoward incident they along with the vehicle were brought at DHQ Thoubal.

After thorough inspection of the vehicle, it is observed that the lock of the vehicle had been broken. Accordingly, the vehicle TVS Ntorq 125 bearing registration No. MN01AQ 0628 black in colour, one 1+ mobile phone with BSNL SIM card bearing mobile No. 9366535613 and one mobile phone Redmi note 8 pro with Airtel SIM card bearing mobile No. 6909004071 were seized from the possession of the two accused persons namely Makakmayum Anisur and Bogimayum Mirja on the same day at 05:25 a.m at DHQ Thoubal. Further, the two accused persons were also arrested at 5:30 am and 5:35 am. respectively.

It may be mentioned that all the necessary formalities under BNSS i.e. preparation of seizure memo and arrest memo by taking videography during seizure could not be done at the spot as some public organized a mob to attack the accused persons.

The arrested person along with the seized articles is handed over to you for taking further necessary legal action against them.
